## **General conditions of participation**

### **1. Excursion**

The excursion to Gamescom takes place as part of the MKW-funded project iStark with the aim of supporting and facilitating the entry into professional life and career planning in Germany for international students with and without a refugee background.

### **2. Registration**

H-BRS reserves the right not to consider the participant's application, especially if the maximum number of available course places is reached. Registration does not constitute a claim to course participation. Participation in a course can only be confirmed after the documents have been checked by the International Office.

### **3. Costs**

The admission ticket is covered by project funds from the iStark project. Any costs incurred for travel to and from the course and for meals must be borne by the participants.

### **4 Cancellation by H-BRS**

H-BRS is entitled to cancel the excursion by giving notice to the participants and thus withdraw from the contract. Claims for damages by participants due to the cancellation of one or both courses are excluded.

### **5. Data protection**

The participant agrees that H-BRS may collect, process and store the personal data required for the proper execution of this contract and provided by him/her (including electronically, if applicable). The personal data provided during registration will only be collected, processed and used for the purpose of executing this contract and only for as long as is necessary for the execution of the contract. The data will not be passed on or made available for use to third parties who are not connected with the implementation and execution of the course. For the purpose of documentation, the name and e-mail address of the participants as well as anonymized statistical data will be passed on to the sponsor and the participant expressly agrees to this.
